#F401 - Narcissism and Narcissistic Disorders

COURSE DESCRIPTION: Material will be provided for the student to review information pertaining to the normal narcissistic stage of development, and so-called healthy narcissism, as described by Edith Jacobson. Primary and secondary narcissism will be defined and potential consequences of narcissistic injury, such as grandiosity, narcissistic rage, and other forms that it may take will be reviewed.

COURSE OBJECTIVES:

- 1. To examine and appraise narcissistic character structure, and its implications.
- 2. To analyze narcissism in the light of relationships, and how others are affected.
- 3. To determine how narcissism presents during treatment and how it affects analysis.
- 4. To examine the differences between narcissistic character and pathologic narcissism.
- 5. To consider how to treat narcissistic patients without judgement.

COURSE STRUCTURE: The instructor will review the reading material and point out the salient points. Students will be required to present case material to the class, pointing out the narcissistic issues present in the case, and how they handled it. They will write a final paper using case material, demonstrating their understanding of the course material.
