**Course Description:** This course will introduce candidates to one of the post-Freudian psychoanalytic theories, Self Psychology. The historical context in which this theory emerged will be presented, beginning with the work of Heinz Kohut. The recognition of the individual's need to organize his/her/their psyche into a cohesive configuration will be explored. Key concepts such as the role of empathy, idealization, mirroring, twinship, and the establishment of self-sustaining relationships between the self and its environment will be analyzed, along with the narcissistic transferences. The evolution of Self Psychology since Kohut will be explored by looking into contemporary Self Psychology theory, relational analysis, and intersubjectivity.

## **Course Objectives:**

- 1. To examine the historical context in which Self Psychology emerged. To analyze what led Kohut to the development of a psychology of the self.
- 2. Candidates will be able to describe the key concepts in Kohut's Self Psychology.
- 3. Candidates will be able to apply the principles of Self Psychology to their clinical work.
- 4. Candidates will be able to analyze and consider the evolution and inclusion of Self Psychology into contemporary perspectives.

**Class I: Introduction to self psychology**. This class will explore the history of Self Psychology in psychoanalysis. The radical innovation brought by Kohut to the field of psychoanalysis will be addressed.

**Class II: The centrality of empathy in self psychology**. This class will analyze Kohut's premise of empathy as "vicarious introspection". The individual's capacity (or lack of capacity) to be aware and able to perceive another's mental states will be discussed.

**Class III: Selfobjects**. Kohut's idea of how an individual's sense of self develops and is sustained will be analyzed. The premise of narcissism as the manifestation of a vulnerable self attempting self-cohesion/organization will be examined.

**Class IV: Self object transferences**. The notion of the displacement onto the analyst of the analysand's need for a responsive self matrix in the context of analysis will be unpacked. The narcissistic transferences will be reviewed.

**Class V: Evolution of self psychology. Part I.** This class will begin to analyze how certain aspects of self psychology have been incorporated in contemporary psychoanalytic theory. We will begin with the impact of Self Psychology on relational psychoanalysis.

**Class VI: Evolution of self psychology. Part II.** This class will analyze the impact of Self Psychology on intersubjectivity. The impact of the therapist on the clinical process will be explored.
